## Lai Sun Development Company Limited HK\$3,600 Million 4-Year Secured Term Loan Facility for the Development of The Hong Kong Ocean Park Marriott Hotel at Ocean Park, Hong Kong

(Hong Kong, 15 May 2015), Capital Court Limited, developer of the captioned hotel and a wholly-owned subsidiary of Lai Sun Development Company Limited (0488.HK) ("Lai Sun"), has mandated Bank of China (Hong Kong) Limited, Bank of Communications Co., Ltd. Hong Kong Branch, The Bank of East Asia, Limited, BNP Paribas, China Construction Bank (Asia) Corporation Limited, Chiyu Banking Corporation Ltd., Chong Hing Bank Limited, DBS Bank Ltd., Hang Seng Bank Limited, Industrial and Commercial Bank of China (Asia) Limited, Shanghai Commercial Bank Ltd., Standard Chartered Bank (Hong Kong) Limited, Sumitomo Mitsui Banking Corporation and United Overseas Bank Limited to be the Mandated Co-ordinating Arrangers and Lenders for arranging a 4-year secured term loan facility (the "Facility").
