The board of directors (“**Board**”) of Lai Sun Development Company Limited (“**Company**”) announces that all the resolutions (“**AGM Resolutions**”) set out in the notice of the annual general meeting of the Company (“**AGM**”) dated 18 November 2021 (“**AGM Notice**”) were duly passed as ordinary resolutions by way of poll at the AGM held on Friday, 17 December 2021 at 11:00 a.m.
