(b) to grant a specific mandate to the eSun Directors to exercise all the powers of eSun to allot and issue new eSun Shares to the Scheme Shareholders in accordance with the terms and conditions of the Proposal and the Scheme;		
(c) to approve the increase in authorised share capital of eSun from HK\$1,250,000,000 divided into 2,500,000,000 eSun Shares to HK\$2,000,000,000 divided into 4,000,000,000 eSun Shares, with the creation of an additional 1,500,000,000 eSun Shares; and		
(d) to authorise the eSun Directors to do all acts and things and to sign, execute and deliver all such documents and to take all such steps considered to be necessary, appropriate, expedient or desirable to give effect to the transactions set out in (a) to (c) above on behalf of eSun.

- Where there are joint holders of any eSun Shares, any one of such joint holders may vote at the eSun SGM or any adjournment thereof (as the case may be), either in person or by proxy, in respect of such eSun Shares as if he/she/it were solely entitled thereto, but if more than one of such joint holders be present at the eSun SGM or any adjournment thereof (as the case may be), the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the Hong Kong branch register of Members in respect of the joint holding.
- Completion and return of this form of proxy will not preclude a Member from attending and voting in person at the eSun SGM or any adjournment thereof (as the case may be) should he/she so wish. In such case, the said form(s) of proxy will be deemed to be revoked.
- Any alterations made in this or any photocopied form of proxy must be initialled by the person who signs it.**

- A Member or his/her/its proxy should produce proof of identity when attending the eSun SGM. If a corporate Member appoints its representative to attend the eSun SGM, such representative should produce proof of identity and a copy of the resolution of the board of directors or other governing body of that Member appointing such representative to attend the eSun SGM.
